# Investment commentary

The top contributors to relative returns this month were holdings in Cyient, Cholamandalam Financial, and Century Pacific. Cyient reported strong quarterly results, with solid revenue growth and better-than-expected margins. Additionally, the market reacted positively to the company's announcement of its DLM division IPO, which removes a previous overhang. Cholamandalam benefitted from the combination of lower inflation and expected rates in India, which is favorable to loans origination and growth, and from market share expansion across its existing operations, which is also favorable to profit growth. Management is executing well in terms of entering new geographies in India while maintaining an efficient cost structure. Century Pacific's share price recovered after a weak May. The company delivered solid quarterly results with tight cost control cushioning pressure from cost inflation.

The biggest detractors from relative returns this month were holdings in MKIF and Bajaj Holdings & Investment. Korean infrastructure business, MKIF, experienced some profit-taking after solid performance year-to-date and amid a weaker month for the overall Korean market. The company also announced plans to raise capital through new share issuance to fund upcoming infrastructure projects. Bajaj's share price corrected following strong performance in May. Its subsidiaries, Bajaj Auto and Bajaj Finserv, continued to deliver strong business performance. Not owning the South Korean materials name, Ecopro, detracted from relative returns this quarter.






# Market capitalisation distribution (%)
